RESOLUTION TO APPROVE AND AUTHORIZE THE ADOPTION OF A NEW BID THRESHOLD IN THE AMOUNT OF \$44,000.00

WHEREAS, the Housing Authority of the City of Linden ("Housing Authority"), a public entity organized and existing pursuant to the Code of Federal Regulations, the U.S. Department of Housing and Urban Development ("HUD"), and the laws of the State of New Jersey, has determined that it is in need of adopting a new bid threshold; and

WHEREAS, the New Jersey Local Public Contracts Law requires public entities to advertise for bids the cost of a particular good and/or service exceeds the bid threshold; and

WHEREAS, specifically, N.J.S.A. 40A:11-3(a) provides that the bid threshold shall be \$17,500.00 unless the public entity has appointed a Qualified Purchasing Agent and adopted a higher bid threshold; and

WHEREAS, Local Finance Notice 2020-14 allows public entities that have appointed a Qualified Purchasing Agent to increase their bid threshold to up to \$44,000.00; and

WHEREAS, the Housing Authority has appointed a Qualified Purchasing Agent by way of Resolution 2022-23; and

WHEREAS, the Housing Authority wishes to establish a higher bid threshold to the extent permitted by the Local Public Contracts Law and Local Finance Notice 2020-14; and

WHEREAS, all procurements under the increased bid threshold shall be conducted by the

Qualified Purchasing Agent and, in accordance with Resolution 2022-16, reviewed by General

Counsel for legal compliance; and

WHEREAS, the Board of Commissioners has determined that it is in the best interest of

the Housing Authority and its overall goal of providing quality, affordable housing to low-income

seniors to approve and authorize the adoption of a new bid threshold in the amount of \$44,000.00;

NOW THEREFORE,

BE IT RESOLVED that the Board of Commissioners of the Housing Authority of the

City of Linden hereby approves and authorizes the adoption of a new bid threshold in the amount

of \$44,000.00; and

BE IT FURTHER RESOLVED that the Board hereby directs that all procurements under

the increased bid threshold shall be conducted by the Qualified Purchasing Agent and reviewed by

General Counsel for legal compliance; and

BE IT FURTHER RESOLVED that the Board hereby authorizes the Executive Director

of the Housing Authority to take any and all necessary administrative actions to implement this

resolution.
